



COACHING AGREEMENT

This Agreement ("Agreement") is made and entered into on _____, 20__, by and between **Be Inspired For Real**, hereafter referred to as "BIFR," and _____, hereafter referred to as "Coach."

1. Purpose

BIFR agrees to promote and feature Coach's services on its platforms, including but not limited to the Be Inspired For Real website, social media pages, and newsletters. Coach agrees to provide coaching services in alignment with BIFR's mission, values, and standards.

2. Term

This Agreement shall begin on _____, 20__, and continue for **six (6) months**, unless terminated earlier under Section 9. Renewal is subject to mutual written agreement.

3. Compensation

- A. Coach shall retain **80%** of all service fees collected from clients referred through BIFR. (*Attach service pricing to Agreement*)
- B. BIFR shall retain **20%** as a platform fee.
- C. Payments from the Coach to BIFR shall be made via **PayPal, Zelle**, or other **mutually agreed method** within five (5) business days of receiving payment from the client.
- D. Coach shall provide proof of payment to BIFR upon request.
- E. Both parties agree to maintain accurate records of transactions for the duration of this Agreement.

4. Coach Responsibilities

- A. Provide accurate and current CV, pricing, and service descriptions.
- B. Maintain professionalism, confidentiality, and ethical standards at all times.
- C. Deliver services as advertised to clients.
- D. Maintain appropriate licensing or certifications, if required by law.

5. BIFR Responsibilities

- A. Promote Coach's services through its platforms.
- B. Provide visibility to its audience, including Facebook followers, social media, newsletter, blog, and website reach.
- C. Forward inquiries to Coach in a timely manner.

6. Indemnity

Coach agrees to indemnify, defend, and hold harmless BIFR, its owners, employees, and affiliates from and against any and all claims, liabilities, damages, losses, and expenses (including reasonable attorneys' fees) arising out of or related to Coach's services, actions, or omissions, including but not limited to claims made by clients.

7. Independent Contractor Status

Coach is an independent contractor and not an employee, partner, or agent of BIFR. Coach is solely responsible for taxes, insurance, and all business expenses related to their services.

8. Confidentiality

Both parties agree to maintain the confidentiality of all non-public business and client information acquired during the term of this Agreement.

9. Termination

Either party may terminate this Agreement with 30 days' written notice. BIFR reserves the right to terminate immediately if Coach engages in conduct inconsistent with BIFR's mission, violates ethical standards, or breaches this Agreement.

10. Governing Law

This Agreement shall be governed by and construed under the laws of the State of _____, without regard to its conflict of law principles.
